VI. CURRENT SITUATION:

The children have continued to live with their adoptive parents. They are all beginning to adjust to being a permanent part of the adoptive family. The children refer to their adoptive parents as "Mom" and "Dad". The children also refer to extended family as though they were the biological family.

On December 4, 2001, this Worker presented the [REDACTED] children to the subsidy committee, and they have been approved for a subsidy. On the same date, authorization to proceed with the adoption was approved by DCFS.

The adoptive parents are very excited to finalize the adoption on the [REDACTED] children. They are very committed to these children.

Bryce is current on his mental health assessment. He is being continuously assessed by the HeadStart Program that he attends daily.

Briauna is current on her mental health assessment. She is no longer receiving services from DDI Vantage. She has graduated from the program. She has met every developmental milestone within normal time frames.
