First Answer: Background Questions

- What is your situation (married, living together, etc.)?
- Do you have children with your partner? Ages?
- You and your partner's highest level of education?
- Do you own a business with your partner?
- Are you and/or your partner employed?
- Do you or your partner have any experience with divorce?

First Answer: Personality Questions

- Do you usually solve your own problems or turn to other people for assistance?
- Do you have a good support system, (family, friends)?
- Do you understand the consequences of divorce (for yourself, your children, financially, etc.)?
- Do you have other concerns (children, domestic violence, substance abuse, etc.)?

First Answer: Recommendations/Referrals

- Domestic Violence - Priority to get out and call authorities.
- Tools available for victims of Domestic Violence
 - Victim Netherlands
 - Safe Together
 - Domestic Violence Support Centre
 - Victim Pointer (a referral service)
 - The Counseling and Reporting Child Abuse

First Answer: Recommendations/Referrals

- Public Assistance
 - Mediation
 - Legal Aid
- Injunctive relief
 - Hiring a lawyer
 - Dealing with the final decision
