## **1. Purpose and Scope**

### **1.2. Purpose:**

The purpose of the Arrest Warrant IEPD is to create and document a national court standard for the arrest warrant exchange using the Global Justice XML Data Model (GJXDM). The IEPD is intended to act as a guide or template for local jurisdictions implementing electronic exchange of information, in this case arrest warrant information. It is expected that jurisdictions that implement the exchange will extend and/or constrain the IEPD to fit their individual needs. Ultimately, as the result of the experience gained through local implementations, the IEPD will be revised with the goal of moving toward a single standardized exchange.

The purpose of developing any IEPD is to achieve the following:

- Facilitate information sharing within the court community and between courts and other justice partners.
- Facilitate the development of consistent and reusable court data components.
- Reduce costs and increase efficiency of information sharing efforts.
- Establish court information sharing policies and procedures.
- Foster collaborative development between the courts and other justice domains.
- Create a common understanding and language between domain experts and technical experts.

Arrest Warrant	This GJXDM draft document is to provide a reference for the requesting agency to the court for an arrest warrant and issuance from the court of an arrest/bench warrant.

##### **4.1.2 Document Sections**

Affiant	The name of the person who swears to an affidavit. This may include a law enforcement officer, a grand jury, etc.
Affiant Agency	Agency that originates the request for a warrant.
Case	A court case.
Court	Court Description

Judicial Officer	A judge or other judicial official that issued a court order.
Offense	Describes an alleged act which may constitute a violation of a criminal statute, ordinance, court order or rule.

Subject	The person or organization of interest.
Vehicle	A motor vehicle.
Warrant Order	An authorization for an enforcement official to perform a specified action such as arresting a person or searching a residence.
Warrant Validation Agency	Agency that holds the physical warrant and confirms the current status of a warrant. This is common in automated warrant systems to enable an automatic locate of a warrant.

Badge Number	Identifier that is either assigned by a law enforcement agency or other entity to each officer. This may be an employee number or a court assigned PIN.
Bail Amount	Monetary amount set for the defendant's bail.

Charge Attribute	Additional information that notifies the court of special conditions (e.g. domestic violence, white collar crime, or court reporting requirements)

Grand Jury Type	Examples include a State wide grand jury, county grand jury or special grand jury.
Hair Color Code	A code representing person's hair color.

Incident Identifier	Ties a subject through biometric based identifiers to a particular incident. Also known as a OBTS (Offender Based Tracking System) or an OCN (Offense Cycle Number).

Interpreter Required Indicator	Set to yes if a person needs an interpreter.

Statute Number	Alphanumerical reference indicating the statute violated within a charge code book (e.g. in VC123.23(a), the 123.23(a) portion is the statute number)
Street Name	A name of a street.
Street Number	A number that identifies a particular unit or location within a street.
Street Post Directional	A direction that appears after a street name.

Telephone Number	A full length telephone identifier.

## 4.2. Minimal Properties Set

Because this is a national model, there are no minimal property sets defined. However, local jurisdictions will likely want to define information regarding the property cardinality in the XML schemas.

## 4.3. Additional Business Rules

The definition of this document has been limited to identifying those elements that are currently in use and in which at least one use case could be cited during the development process. While other elements may be used in specific courts or jurisdictions, the intent of the IEPD is to compile the commonly used information to provide a basic structural template for the creation of jurisdictionally based messages.

The following are miscellaneous notes that were developed during the analysis and creation of the exchange document as it pertains to court and jurisdictional business rules and procedures:

- The requesting agency will likely be a law enforcement agency or prosecutor. However, it may also be a court who is issuing a bench warrant document.

- The subject vehicle indicates the vehicle(s) owned or otherwise associated with the subject (e.g. subject stole the vehicle)
- A Judicial Officer may or may not be associated with the court. This is because sometimes visiting judges or judges from neighboring jurisdictions may substitute for the duty judge during a vacation for example.
- In general, the contact information for the requesting agency will be used if a specific requesting person is not available.
- The NCIC Gang Database Identifier is a person based identifier that is used to query the NCIC Gang Database and retrieve gang affiliations. This was added to NCIC in the Summer of 2005.

## 6.2. Process:

In March, 2004 the COSCA/NACM Joint Technology Committee was asked to choose from a list of common inter-agency and inter-departmental justice messages and rank the most commonly used court forms and communications. The top four selections were citation, protection order, sentence, and warrant documents. Because these are the most common forms used by courts and therefore, the most common communication data exchanges, these four selections have served as the basis of the initial IEPD work performed by the National Center for State Courts.

A key element of the project was to establish a court Joint Standards Development (JSD) Team to participate in the development of the IEPD. The JSD team included participants from the courts, law enforcement, SEARCH and the justice industry. (See Section 6.1)

The first step in the creation of reference documents is to solicit court forms and electronic data exchanges from State Court IT Directors. In late May and early June, 2004, an updated listing of State Court IT Directors was completed and an e-mail was sent soliciting forms and electronic messages already used by courts for traffic and misdemeanor citation and domestic violence protection orders. The following states sent information for warrant document:

- California
- Minnesota
- Nebraska
- New Jersey
- South Carolina
- Texas
- Virginia
- Utah

Once the forms and other data transmission source documents were collected, both NCSC and contract staff extracted the data elements from the forms and organized them by state and then grouped them by like element. After performing the first analysis, and based on input from other GJXDM related meetings, it was determined that it would benefit all to create a data relationship model, or domain model, so as to better understand the organization, relationships and groupings of data involved in the exchange. The domain model is a pictorial representation from the business perspective of the groupings, Sections, Components and Elements, that make up the exchange.

A JSD meetings was held for developing the arrest warrant IEPD in Atlanta, Georgia on November 4, 2004. During the meetings participants were asked to review the proposed

domain model to determine: the appropriateness of the groupings, the need for each of the elements within the groupings, and the need for additional elements not present.

Following the JSD meetings URL Integration, a sub-contractor to the NCSC, used their excellent data mapping and organization software to map the elements to the GJXDM and to define and associate new extension elements where needed.

Subsequent follow-up work was conducted through WebEx conference calls with the JSD team. This included vetting the resulting domain model, vetting the descriptions and definitions of both GJXDM and extension elements for appropriateness, and reviewing the final IEPD once generated.
