In a previous Order, the Court prohibited the media from taking photographs and videotape of any of the jurors in this case. The Court hereby prohibits any members of the media from: (1) contacting or communicating with any jurors, their family members, friends, co-workers, and acquaintances; (2) publicly identifying any juror; (3) publicly providing any information that was not disclosed in court and that could reasonably lead to the identification of a juror; (4) following or monitoring any juror, including while entering or exiting a courthouse parking lot, while entering or exiting the courthouse, and while in the courthouse; and (5) photographing, video recording, documenting, investigating, or researching a juror's license plate number or any other information that could reasonably lead to the discovery of a juror's contact information, home address, or work address.

This Order will be in effect until the trial (including any sentencing hearing) is completed and applies to all 24 jurors, even after they are discharged if such discharge occurs before the completion of the trial (including any sentencing hearing). A violation of this Order will result in the violator and any organizations with which he or she is affiliated being immediately barred from the courthouse and courthouse premises during the remainder of this trial.

The Court wishes to be clear that this Order was not triggered by any improper conduct by the media. As far as the Court is aware, the media has complied with all of its Orders and has observed proper decorum in the courtroom at all times. The Court issues this Order to protect the privacy of the jurors during the trial and to address the concerns voiced by prospective jurors in jury selection.
