

# National Scan of Remote-First and Remote-Friendly Court Rules

A Resource from the  
Pandemic Rapid Response Team



In the summer of 2020, the Conference of Chief Justices and Conference of State Court Administrators passed a resolution “[In Support of the Guiding Principles for Post-Pandemic Court Technology](#)” which called for courts, among other things, “to adopt a remote-first or remote-friendly approach[] when moving court processes forward.” Many state courts have begun implementing rule changes to establish a remote-first or remote-friendly approach that provides access and protects the rights of litigants. This resource collects those rule changes as a resource for courts considering similar rules changes in the following areas:

- Remote format scheduled by default

And that determination shall be made with the agreement of all parties in the case.]
